

THE 10 CLUB LOCATIONS SPAN PINELLAS COUNTY AND ARE STRATEGICALLY LOCATED IN COMMUNITIES THAT HAVE BEEN IDENTIFIED AS HIGH NEED. OVER 80% OF THE YOUTH SERVED QUALIFY FOR THE FREE AND/OR REDUCED LUNCH PROGRAM, AN INDICATOR OF FEDERAL POVERTY LEVEL. BOYS & GIRLS CLUBS OF THE SUNCOAST HAS THREE FOCUS AREAS INCLUDING ACADEMIC SUCCESS, HEALTHY LIFESTYLES, AND CHARACTER DEVELOPMENT PROGRAMMING.
